One Ball 2025 Tournament Rules

- 1) "Event" is defined as each tournament date.
- 2) The One Ball Event will be held on September 20th, 2025. The event will start no earlier than 1:00 pm beginning with a 10 minute warm-up period.
- 3) USBC Rules will apply.
- 4) The Event is open to adult bowlers with a 2024-25 or 2025-26 USBC Standard Membership. USBC Membership card or Temporary Receipt must be presented upon submission of the paid and completed entry or at time of check-in. Additional proof of identity will be required upon request. If proof of applicable USBC Membership cannot be verified a \$5 participation fee will be assessed.
- 5) Entry Forms are to be fully and accurately completed. Inaccurate or false information provided on the Entry Form may Void the entry and result in Forfeiture of the Entry Fee at the full discretion of Tiki Lanes. Entry Forms may be completed on paper or through our online form.
- 6) Average (All Averages are subject to verification):
 - a. Highest USBC 2024-2025 League Average of 21 games or more.
 - b. If none, bowl scratch.
 - c. Average Adjustments will be made for Sport or Challenge Leagues.
- 7) There will be Open, Women's, Open Senior (50+) and Open Super Senior (70+) Divisions. Divisions may be combined if there are fewer than 8 bowlers in any Division.
- 8) Entry Fee will be \$40 per Event (\$14 Lineage, \$1 Expenses, \$25 Event Prize Fund). Reserved Entries may be paid by Cash or Check. Reserved Entries may be paid using Venmo to @TikiLanes with a \$2 Convenience Fee – total due \$42. Card payments not accepted. Walk-ins must pay Cash.
- 9) Reserved Entries will close on September 17th, 2025. Reserved Entries require a completed Entry Form and payment of the Entry Fee. Walk-in entries will be accepted until 12:15 pm on the day of the Event if lanes are available and there are no more than 5 bowlers per lane. Walk-in entrants must pay the Entry Fee in Cash plus a \$5 walk-in fee. No Entry Fees will be refunded after the Reserved Entry closing date.
- 10) Handicap will be 80% of 220.
- 11) Bowlers will be able to warm-up with more than one ball. At the conclusion of the 10 minute warm-up period bowlers will determine their Declared Ball. Bowlers will identify the Declared Ball to the other bowlers on the Lane pair and by entering the ball's Manufacturer, Model, Color and Serial Number on the Score Sheet or other form. The Declared Ball is the only ball a bowler may use during the course of the tournament. All other equipment will be moved away from the bowler's and table seating area.
- 12) A bowler whose Declared Ball is damaged during the normal course of competition and at no fault of the Bowler may be granted a replacement. The damage must be deemed to change the Declared Ball's performance or the Bowler's ability to hold or grip the ball sufficiently or safely. If this situation occurs it will be handled on a case by case basis and will be at the full discretion of the Tournament Manager.
- 13) Use of a ball other than the Declared Ball will result in disqualification. A bowler who is disqualified will Forfeit all money paid for Entry Fees, Brackets and Jackpot.
- 14) After each game bowlers will move 1 pair right within their Division's Lanes, subject to bowler minimums.
- 15) Places will be determined based on the 4 Game Total plus Handicap. Max Score is 300.
- 16) Score disputes should be reported immediately to the Tournament Manager. Score disputes occurring during Games 1, 2 or 3 must be reported before the bowler throws a ball in the next game. Score Disputes occurring in the 4th game must be reported immediately upon completion of the 4th game. Score disputes not reported in accordance with this Rule will not be considered for review.
- 17) Ties for Paid Places will be broken by a 1 Game Roll-Off with Full Game Handicap. If bowlers are still tied after the 1 Game Roll-Off then a 9th and 10th Frame Roll-Off will be repeated until the tie is broken. 9th and 10th Frame Roll-Offs will be completed with 20% of the Full Game Handicap.
- 18) Prize Payouts will be based on the number of paid entries for each event. Prizes will be paid to no more than 20% of participants. Prize Payouts will be determined during competition. 100% of the Prize Fund will be returned. Prize payouts will be rounded at the discretion of Tiki Lanes.
- 19) Prize Payouts will occur after all pertinent averages have been verified. Prize Payouts will be completed no more than seven (7) days after the completion of each event, unless a pertinent average cannot be verified. Prizes Payouts may be hand delivered or mailed, if mailed a check will be made payable to the entrant and sent to the address on the Entry Form.
- 20) Tiki Lanes's liability to any entrant, or entrant's authorized representative, shall not exceed the Entry Fee for any reason.
- 21) Participants are to conduct themselves as adults and respect others, Tiki Lanes and it's staff. Tiki Lanes reserves the right to refuse a bowler's entry into any Event or remove a bowler from competition.
- 22) By entering this Tournament Series, all participants agree to the use of his or her Name, Image and Likeness by Tiki Bowling Lanes, Inc for any purpose.
- 23) Situations not covered in these Rules will be at the full discretion of Tiki Lanes or the Tournament Manager. Tiki Lanes reserves the right to make necessary corrections to errors in the Rules.
